TERMS & CONDITIONS

1. Administration Fee

Orders under \$50.00 Excluding G.S.T. a fee of \$7.00 will apply to cover Processing & Handling.

2. Payment(New Zealand)

- a) Off all Goods and Services strictly 20th month following date of invoice.
- b.) Will be made by cash, or by cheque, or by bank cheque or automatic payment.
- c.) All first orders are on a cash basis until terms of credit are set up for repeat orders. Payment for the goods is due on pick up.
- d.) If payment is not made by the due date Crystal Colour Graphics Ltd reserves the right to charge interest at the current overdraft rate charged to Crystal Colour Graphics Ltd Bank plus 2.5% commencing from the due date. Should any judgement be entered against the buyer for money owing to Crystal Colour Graphics Ltd then interest at the rate specified in this clause shall accrue on all money owing under any such judgement until payment is made in full. All accounts will be put on stop credit after 60 days of non payment of outstanding monies.

3. Payment (Export).

All export orders are to be accompanied by either of the following methods of payment, before being processed with in Crystal Colour Graphics Ltd production.

- 1.) Payment with order.
- 2.) 60-day post dated bank cheque.
- 3.) 60-day Letter of credit.

4. PRIVACY

I/We hereby irrevocably authorise any persons or company to complete and furnish to you any information in response to your credit enquires.

I/We further authorise you to furnish to any credit agency details of this application and any subsequent dealings I/We may have with you as a result of this application being actioned by you.

5. PROPERTY

- a) The ownership of goods will remain Crystal Colour Graphics Ltd until payment has been made in full of the purchase price for the goods and of all monies for the time being due and owing to Crystal Colour Graphics Ltd.
- b) The Buyer will on request assign to Crystal Colour Graphics Ltd any claim the buyer may have against any sub-purchaser in respect of the sub-purchaser of goods supplied by Crystal Colour Graphics Ltd to the Buyer.
6. Crystal Colour Graphics Ltd reserves the right to manufacture to the industry standards of plus or minus 10% and to supply and charge the amount produced. The buyer must advise in writing at the time of placing the order, if any variation is required.
